Dear Mrs. Loewe,

Thankyou for your prompt reply to my correspondance requesting a pardon on my pending Ayahuasca / DMT charges in Ashe county.

I am in a difficult financial situation due to my ownership of a California "C" Corporation called United Business Technologies which I founded in 1995. I allegedly owe the IRS \$700,000. I have avoided bankruptcy for several reasons however it still remains as a possible solution.

I cannot afford a good lawyer for my criminal defense. I have been forced to prepare my defense under the most difficult conditions. Excessive bonds precluded my ability to make bail. After an illegal search of my home produced 11 ounces of marijuana the bond was set at \$30,000 with "Cash Only" stipulations. The warranted search of my home produced 1/10th of a gram of DMT and bond was set at \$350,000

The pretrial detention on the marijuana case effectively forced me to plead guilty to Felony "Maintaining a Residence for Sales of Controlled Substances". I never sold it. My choice was to sign the plea or go back to jail. This prosecution tactic does not honor truth or justice. When the judge asked me to place my hand on the Bible I said, "I have too much respect for the book to swear on it." When I was asked to raise my right hand, I raised my left hand which the judge ordered me to correct.

My laptop contains phone numbers and email addresses for professional affiliates. I cannot access my laptop because a search warrant was issued for it seeking ledgers of controlled substance sales which do not exist because I do not sell anything illegal. I have been cut off from all my contacts and medicinal research notes that I need to prepare an honest defense.

On May 20th, after 11 months in jail, I will sign a plea that will cause my release. I am under duress and will confess to whatever the prosecutor demands. This is un-american however this is a common practice. Successful district attorneys have high conviction rates.

I understand that prior to my admission of guilt on May 20th that your office cannot help me in obtaining a pardon. I do not deny the fact that I extracted some DMT from wild grass in my front yard. I am guilty of personal research and guilty of spiritual practice. I am educated in both the chemistry and in the spiritual application of Ayahuasca.

Perhaps you can help me prior to May 20th by referring me to the North Carolina government office that would be responsible for issuing an "Ayahuasca Church" permit. An Ayahuasca Church already exists in North Carolina however all my attempts of contacting them have been unsuccessful.

I have been served Ayahuasca and trained in various preparation techniques by Brazillian and Puertorican "shamans" who learned the traditional process from their elders. I practice with portals such as the ancient Taino ceremonial site in Puerto Rico. Here in Black Mountain, NC is another portal that was constructed by native Indians. The site has been preserved by a former CIA agent who practiced "out of body remote viewing" for the U.S. Government. The site is now a center of spiritual study open to the public where I practiced. Mosaic priests used an "ephod". Exodus 28:17-20, 1 Sam 23:9-10
In the latter verse King David used the ephod to inquire of God.

In my previous letter I mentioned my medicine research work. I own SyrianRue.org which shares knowledge about replacing pharmaceutical anti-depressants with plant medicines. Edgar Cayce was a famous spiritual medicine healer who promoted natural holistic medicine. I work with people indirectly related to EdgarCayce.org, Association for Research and Enlightenment in Virginia Beach, VA. They are familiar with my criminal case here in North Carolina.

My work with DMT/Ayahuasca is legitimate with respect to the spirit of the law that protects the practice under constitutional Freedom of Religion. Can you please help me to obtain a permit recognized by the State of North Carolina to prevent a future occurrence of criminal charges related to my studies? Can you help me with this prior to May 20th?

After May 20th I will be convicted. I merely desire freedom and the pursuit of happiness. Please consider a pardon of a felony drug conviction which may exclude me from grants and medicine research sponsorships.

Thankyou for your time on this matter and your work to uphold the spirit of the law.
